## TEACHING EXPERIENCE

### Graduate Courses

#### **Latin American Migration and Transnationalism**

Department of Sociology, Syracuse University, Spring 2010

This graduate-level multidisciplinary course examines issues related to Latin American migration to North America, Europe and Asia, and the transnational relationships that link migrants with people in both their sending and receiving communities. In particular, we look at case studies of migrants from Mexico, Central America, Brazil, Cuba, Puerto Rico and the Dominican Republic. We discuss how immigration and refugee policies, international trade agreements, foreign policy, and domestic political and economic conditions shape the context of migration in both sending and receiving societies as well as how emigration impacts the countries of origin and how migration varies across the region. The course is integrated with the Program on Latin America and the Caribbean (PLACA) speaker series and the annual PLACA conference and through the speaker series and conference, students have the opportunity to meet with some of the authors from the course and talk about their work. Featured speakers include Alfredo Lopez (Physician and former migrant worker), Maria Cristina Garcia (Professor of History at Cornell University), Jorge Durand (Professor of Anthropology at Universidad de Guadalajara) and Robert Courtney Smith (Professor of Sociology at Baruch College and CUNY Graduate Center). Through participation in the conference and engagement with speakers, students gain professional development within the field of immigration research.

#### **Sociology of Immigration**

Department of Sociology, Syracuse University, Spring 2009, 2011, Fall 2014, Fall 2017, Spring 2020

This graduate-level course provides an overview of issues related to immigration to the United States. In the first part of the course, students focus on the history of immigration and immigration policy. In addition, students learn about sociological theories of immigrant incorporation as well as specific issues related to the second-generation children of immigrants including their educational, labor-market and transnational experiences.

#### **Ethnic Inequalities and Public Education**

Department of Sociology, Syracuse University, Spring 2005

This graduate-level course examines racial-ethnic stratification and related issues in the context of the U.S. school system. The course provides an overview of theoretical perspectives on race, ethnicity, and the social contexts of education as well as empirical research on ethnic inequalities in public schools. Major themes include school segregation, education of immigrant and bilingual children, racial-ethnic

achievement gaps, intersections between race and gender related to education, family-school relationships, and routes to higher education.

## **Undergraduate Courses**

### **Introduction to Sociology**

Department of Sociology, Syracuse University, Multiple semesters Spring 2018-present

This lower-division undergraduate course introduces students to sociological theory and research. The course covers a wide range of topics in the field of sociology.

### **Sociology of Families**

Department of Sociology, Syracuse University, Multiple semesters Fall 2022-present

This lower-division undergraduate course (cross-listed with Women's and Gender Studies) examines contemporary research on families. It explores topics such as household labor and child care, LGBTQ families, immigrant families, marriage, divorce, cohabiting, elder care and other topics related to families. In the course the students do a life history interview on a topic related to families and write a paper on that interview and its relationship to the academic literature on families.

### **Racial and Ethnic Inequalities (Previously Ethnic Inequalities and Intergroup Relations)**

Department of Sociology, Syracuse University, Multiple semesters 2004-2022

This lower-division undergraduate course (cross-listed with Women's and Gender Studies) explores contemporary research on racial and ethnic inequality in the United States as well as theoretical perspectives related to racism and ethnic incorporation. Topics covered include the intersections of race, class and gender, residential and school segregation, immigration policies, and ethnic inequalities in income, wealth, and education.

### **Latin American Migration and Transnationalism**

Department of Sociology, Syracuse University, Spring 2011

This mid-level course in Sociology and Latino Studies examines issues related to Latin American migration to North America, Europe and Asia, and the transnational relationships that link migrants with people in both their sending and receiving communities. During the course of the semester, students are engaged in a service-learning project at local immigrant-serving institutions and write ethnographic field notes and research papers based on participant observation at their field sites. In this seminar-style course, students discuss how immigration and refugee policies, international trade agreements, foreign policy, and domestic political and economic conditions shape the context of migration in both sending and receiving societies as well as how emigration impacts the countries of origin and how migration varies across the region.

### **Sociology Senior Thesis**

Department of Sociology, Syracuse University, Spring 2015, Fall 2015, Fall 2016

This course provides senior sociology majors with an opportunity to design, carry out, and present their own independent research.

### **Introduction to Research**

Department of Sociology, Syracuse University, Fall 2013, Spring 2014

This course is an introduction to quantitative research methods. Students learn a variety of quantitative research methodologies and learn introductory programming in SPSS.

### **Immigration Processes and Immigrants in the United States**

Department of Sociology, Syracuse University, Fall 2005

This upper-division undergraduate class provides an overview of issues related to immigration, with a primary focus on the United States. The course focuses on the history of immigration and immigration



policy, processes of international migration, differential incorporation of immigrant groups into U.S. society and labor markets, and gender and family issues related to immigration and immigrants. Toward the end of the class, the course examines issues of immigration and citizenship in an international comparative context.

### **Civic Engagement Research Seminar**

Citizenship and Civic Engagement Program, Fall 2014, Spring 2015, Fall 2015, Spring 2016

This course provides students who are juniors in the Citizenship and Civic Engagement Program an opportunity to complete an independent research project on a topic that will lead to their Action Plan in their senior year.

### **Critical Issues for the United States**

Maxwell School of Citizenship and Public Affairs, Fall 2008, Fall 2011

This lower-division undergraduate course for first- and second-year students is a team-taught course in the social sciences that explores the meaning of citizenship in the United States as well as particular issues of contemporary importance such as U.S. elections, immigration, and educational inequality.

### **Social Problems**

Department of Sociology, University at Albany, Summer 2001

This lower-division undergraduate course explores social problems in the United States and internationally through a human rights perspective.

### **Social Issues**

Department of Sociology, The College of Saint Rose, Spring 2000

This is an introductory undergraduate course required of all sociology majors in which students are provided with an overview of various fields of research in sociology and conduct original research using inductive interviews.

### **Political Sociology**

Department of Sociology, University at Albany, Summer 1999

This is a lower-division undergraduate course on the major perspectives on politics and power in political sociology. Major themes are theoretical perspectives on power and inequality, the meanings of democracy, the process of democratic transitions, globalization, development, and social change.

### **Immigration**

Department of Sociology, University at Albany, Fall 1998

Co-taught with Distinguished Professor Richard Alba

I participated in the design and teaching of this upper-division undergraduate writing intensive course with Richard Alba. Major themes are theories of international migration, theories of immigrant incorporation, gender differences in migration, and case studies of particular migrant groups. A portion of the course is also designated for student writing issues in general.
